

ACRA REPORTS AVAILABLE FOR PURCHASE VIA INTEREQ - COLLABORATIVE INITIATIVE OF CRIMSONLOGIC AND BIZINSIGHTS

Q1. Where is the BizInsights data obtained from?

A1. A significant portion of the BizInsights' report products and data solutions are obtained from the full ACRA database. BizInsights products also contain derived data and valuable insights from the raw ACRA data. Example – The Enhanced Business Profile has an Annex containing Past Directors and Shareholder chart. This information is derived by BizInsights from the whole ACRA database containing of 120 years of historical data and latest data.

Q2. What is the relationship between ACRA and BizInsights?

A2. The Accounting & Corporate Regulatory Authority (ACRA) is the official company registry in Singapore. BizInsights is a licensee of the ACRA database with its core report products approved and co-branded with ACRA.

Q3. Is BizInsights' reports the same as ACRA BizFile+ reports?

A3. No. Whilst our Business Profile Report and the ACRA BizFile+ Business Profile report have similar content; it is not the same. BizInsights also has more report types with other unique value propositions compared with ACRA services.

Q4. How often is the information database at BizInsights updated?

A4. The information is updated on daily basis with data received from the ACRA. Every report delivered is produced fresh from this updated database.

Q5. What is the average processing time to receive the report after submission?

A5. 30 minutes.

Q6. I filed an update today of a director change in my company to ACRA, how soon is this available in BizInsights?

A6. All filings, like change of Director, made to ACRA will be processed before being available to all its licensees, like BizInsights. This kind of Direct change filing usually takes 1 day before it is reflected in our report.

Q7. What types of reports are available in InteReq?

A7. Three types of reports are available. The Business Profile Report (BPF), Enhanced Business Profile Report (EBPF), and the People Profile Report (PPF). Click on the links below to view the sample reports.

The Business Profile Report (BPF) data will vary depending on the type of entity selected. For instance, shareholders' data will be available in the Business Profile Report (BPR) for a company whereas the Business Profile Report (BPR) for Limited Liability Partnership (LLP) will have information about its Partners

Q8. What report can be available if the entity is non-live?

A8. The Business Profile Report will be available even if the entity status is Cancelled, Terminated, or Struck-Off.

Q9. How can I search for an entity or person on BizInsights?

A9. Search on corporation can be done using UEN Number or the full or partial corporate entity's name. Search on people can be done using NRIC, FIN, Passport Number and name.

Q10. What types of entity information are not available from BizInsights?

A10. Societies and the new Variable Capital Company (VCC) are examples of entities not available. VCC profile information is only available directly from ACRA. Ministry of Society has profile information on societies (like churches) registered with them.

Q11. How long will purchased reports be available for download via InteReq?

A11. It will be available for 7 days from the date of purchase
